Data Process Strategy Recommendations

Sydney Edlund

Center for Outcomes Research and Education (CORE) completed their work and submitted their final report and recommendations in early April 2023.

Sydney Edlund provided an overview of CORE's 28 recommendations and shared OPSC's prioritized recommendations for 2023 implementation:

- Give patients/family members a unique login so they can check and update information over time (5a)
- Add patient race/ethnicity and patient language to the Request for Conversation (1a & 1b)
- Add an intake interview question to the Request for Conversation (2a)

- Make small changes to existing questions (2d & 5c)
- New or revised Resolution Report questions (including the satisfaction question) (4a-4h)

Task Force Discussion

Bob Joondeph asked OPSC staff to explain their thinking behind the recommendation "Add an intake interview question to the Request for Conversation (2a)".

 Sydney responded that asking people how they learn about EDR is critical to understanding which communications channels being used to share about EDR have been successful and why.

EDR Outreach Activities Update

Miranda Brown and Mireaya Medina, Brink Communications Miranda Brown and Mireaya Medina presented an overview of the strategic communications and outreach plan Brink Communications (Brink) developed for OPSC's EDR program. The overview included information about priority audiences, key findings from stakeholder interviews, communication strategies, and next steps.

Anthony Jackson shared his longstanding support for outreach to underserved communities in Oregon. He offered to provide future outreach support to the Task Force as a non-member, dependent on his availability.

EDR 2023 Annual Report Beth Kaye

Beth reported that the EDR 2023 annual report will provide a status update about progress made and next steps toward three identified goals:

- Update EDR data process strategy.
- Develop a strategic communication plan to increase awareness about EDR that prioritizes equitable information dissemination.
- Increase statewide capacity to respond to and learn from medical harm events.

The report will also include EDR program use data.

Task Force Discussion

Margaret Mikula identified an opportunity to explore baseline for communication and resolution programs (CRPs) in Oregon—who has programs and where are they at in their program development—to better understand what the goals are, which may be raising existing programs to the same level or starting new programs.






